#### 55TH SESSION PROCEEDINGS

The 55th session of the Virginia State Association of Free Will Baptists convened at the First Free Will Baptist Church of Roanoke on Thursday evening, June 24, 1993, at 7:30 p.m.

The session was opened by singing "He Abides". Prayer was offered by Jeff Crabtree.

Welcome was extended by the host pastor, Jeff Crabtree. Response was given by the clerk, Walter Statzer, who then introduced the officers of the Virginia State Association of Free Will Baptists, concluding with the Moderator, Daniel Merkh. Brother Merkh then called the meeting to order and proceeded with the business.

Motion was made to accept certain changes in the constitution of the Virginia State Association of Free Will Baptists. (These printed changes of the constitution were distributed to the congregation.)

A motion was also offered to table this motion until the Friday session. (This motion was passed)

Offering was received in the amount of \$91.26. Offertory music was an instrumental presented by Ben Crabtree and Jenny Preece.

The Worship service was opened with the congregation singing "We'll Work Till Jesus Comes". Prayer was led by Danny Baer. Special music was rendered by Donna Crabtree. Ralph Flannary brought a message on the subject of "Stewardship of substance" using scripture from 1 Cor. 4:1-2.

Meeting was closed with prayer by Fred Bates.

The Friday morning session was opened by singing "I'll Fly Away".

dismissal and giving thanks for noon meal was led by J. D. Kilgore.

Friday afternoon session was opened with singing "He Included Me".

Devotions were conducted by Daniel Merkh.

### **OLD BUSINESS**

Motion was passed to accept the report of the Special Finance Committee of Virginia Assoc. of FWB.

Motion was made to amend item number two in the Finance Committee Report to read as follows "The promotional secretary will report to the Executive Board to whom he is answerable, in January and June at which times he will give complete financial reports including actual and projected income and expenses, and that he be elected by Virginia State Association of Free Will Baptist for a two year term".

Motion was passed to accept the budget of the Virginia State FWB Finance Committee.

Motion passed to remove from table item concerning incorporation of Virginia State Assc. of FWB work.

Motion passed to receive the report of Planning Committee concerning incorporation of Virginia State Assc. of FWB work, deleting the word "creed" from articles of incorporation. (section six)

### **NEW BUSINESS**

Motion passed to accept resolution concerning our FWB Covenant and send it to the National Assc. of FWB.

Motion passed to receive Registration Committee report. This committee reported 22 ordained ministers, 7 deacons, 17 lay delegates and 34 visitors for a total of 80 registered.

Motion passed to receive Virginia State Assc. of FWB treasurer's report.

The following names were submitted for the memorial prayer: Madge Statzer, Frank Hayden, Margaret Carr, Johnny Dotson, Ida Carter, Nora Taylor, Earl Barnett. Memorial prayer was led by Dale Burden.

Following delegates were elected to the National Meeting in Louisville, KY: Gaye Sutton, Glenna Slemp, Roberta Blanton, Margie Blevins, Nora Brimer. Alternates: Joyce Sterling, with Va. State moderator empowered to fill any vacancy.

Motion passed to give rising vote of thanks to officers serving and to host church for their service in this meeting.

Motion passed to remove from the table the proposed constitutional changes.

After lengthy discussion on constitutional changes, a motion was passed to table this motion.

Motion carried to change standing rule number seven (7) to read \$35.00 instead of \$20.00, and would be as follows. "Each member Yearly (or district) Association is to send \$35.00 per church in its association to this State Association for National dues, plus an offering to help defray the expenses of this associational meeting and the printing of the minutes. (1982)"

Motion passed to include constitution and by-laws in minutes each year.

Motion passed to adjourn, closed with prayer by Jennings Dotson.

# RESOLUTION REGARDING OUR FWB COVENANT

Whereas our historic and scriptural Church Covenant has been a blessing to our denomination and, along with our Treatise, has formed the basis of our fellowship, and,

Whereas a controversy has arisen in our midst as to whether our Covenant, particularly the statement regarding our promise to abstain "...from all sanction of the use and sale of intoxicating beverages..., " should be firmly adhered to in this age and in all cultures,

Be it resolved that the Virginia State Association of Free Will Baptists reaffirm its belief in our Covenant, that we state our conviction that the sale, sanction and consumption of intoxicating beverages is a sin (Proverbs 23:19-21, 29-35, Heb. 2:15); that we send this resolution to our National Association when it meets in July, 1993, calling upon our National Body to require of its officers, board members and missionaries a firm commitment to our Covenant, and that this Covenant be required of all our Free Will Baptist mission churches on all our fields.

# "Report of the Special Finance Committee of the Virginia State Association"

In keeping with the instructions recorded on page 7 of the 1992 minutes, the finance committee offers the following report. We met three times since the 1992 State Meeting: August 21, 1992; January 18, 1993; and June 24, 1993. Recognizing the diversity among our ranks, we believe the following plan will work for the Virginia State Association of FWB and move for its adoption.

### Financial Support Philosophy for the Virginia State Association of Free Will Baptists

Since the FWB churches of the Virginia State Association are being asked to support State works, only those ministries which are part of the State operations and are directly under the authority and control of the State Association or under the authority and control of the National Association of Free Will Baptists will be supported by giving through the Virginia State Association and promoted by its employ-

#### State Promotional office.

- Begin with a \$15,000 budget. \$7,500.00 part time salary; \$7,500.00 to cover all expenses. All excess income will be divided equally between promotional expenses and projects supported by the Virginia State Association of Free Will Baptists (e.g. Home Missions, etc.).
- The promotional secretary will report to the Executive Board to whom he is answerable, in January and June at which times he will give complete financial reports including actual and projected income and expenses, and that he be elected by Va State Assc. of FWB for 2 yr. term.
- 3. This office will have an annual audit by a CPA.

### Suggestions for supporting the State Promotional Office

- Have a "Wilton Dail" offering on the first Sunday in June of each year for the State work. Ask for ten percent (10%) of the general offering of that day to be given to support the state work. A historical profile of Wilton Dail is being written to help promote this day.
- In addition to the 10%, encourage all local church members to give three dollars (\$3.00) per year to the state work.

### CONSTITUTION OF THE VIRGINIA STATE ASSOCIATION (Adopted June 16, 1989)

#### PREAMBLE

We, the FREE WILL BAPTISTS of the State of Virginia, realizing the importance of a higher degree of cooperation and a greater spirit of unity, do ordain and constitute this Constitution and By-laws for the government of the State Association of Virginia and upon its adoption void any previous rulings, customs, practices or patterns heretofore followed.

### ARTICLE I NAME

The name of this association shall be known as the VIRGINIA STATE ASSOCIATION OF FREE WILL BAPTISTS.

# ARTICLE II PURPOSE

The object or purpose of this organization shall be to unify the efforts of various local associations of this state and adjacent territory to devise and execute measures for the extension of Christ's Kingdom in this world by all of our churches.

### ARTICLE III SECTION 1 MEMBERSHIP

This State Association shall be comprised of those Free Will Baptist Yearly (or District) Associations who are in total agreement with the doctrines and system of church government of the Free Will Baptists as stated in the most current <u>Treatise of the Faith and Practices of the Original Free Will Baptists</u>, and who are in agreement with the declarations of this Constitution.

This Virginia State Association shall itself be a member of the National Association of Free Will Baptists and shall support all phases of the denomination's work as much as possible. This membership is voluntary, submits to no veto or dictorial power, and can be discontinued at any time.

# SECTION II ADMISSION OF MEMBERS

Any organized Free Will Baptist Yearly (or District) Association desiring to unite with this association, which maintains gospel order and agrees with the position stated herein concerning doctrine and

church government, which is in favor of our evangelistic enterprises as stated in the final two paragraphs of our Free Will Baptist church covenant, may be received into this Virginia State Association in accordance with the procedure set forth in the <u>Treatise</u>, Part IV, Chapter III, Section V, A3, D, & E.).

# SECTION III MEMBERSHIP REPRESENTATION

A. Standing delegates:

- "All ordained ministers and deacons in good standing belonging to the Virginia State Association upon registration become members in full standing and constitute the standing delegation of the Association." (Proposed 1965)
- All duly elected officers and members of standing committees or boards of this association.
- B. Elected delegates; Each association within the state shall be entitled to five (5) representatives to be chosen from the laity of the local association (1981) and two (2) additional delegates for each quarterly meeting to be chosen by the respective quarterly meeting (1989). Also, each local church shall be allowed one (1) delegate (1989) to the state meeting.

#### **ARTICLE IV**

DISCIPLINE: The State Association shall have the right to settle any question of discipline, doctrine, or usage that may properly come before it from any association, quarterly meeting or church composing said state association of the Free Will Baptist Church, or act upon any appeal that may be made by any body belonging to said association. Said appeal shall have been written and properly signed by the constituent body or bodies. Such appeals are to come before the state association after having been appealed from the lower body to the next higher body.

### ARTICLE V SECTION I

- A. OFFICERS: The officers of the State Association shall consist of a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, a Treasurer, and five member Executive Board.
- B. OFFICERS' ELECTIONS: The Moderator shall appoint a Nomination Committee consisting of at least three (3) members at the beginning of each session. They shall select a nominee for each office that is vacant and present the list to the

Moderator. The Moderator shall read the name that is nominated for each office, and declare the floor open for additional nominations. Each office shall be filled by a standing vote of the body at the close of each regular session, except the clerk and assistant clerk which shall be for a period of four (4) years (elected on leap year) or during good behavior, and the executive board which shall be elected according to a five (5) year rotation.

#### **SECTION 2**

STATE EXECUTIVE SECRETARIES: When needed, the state executive secretaries of department work shall be as follows: foreign missions, home missions, young people's work, Sunday Schools, and education, and shall be nominated by the Nominating Committee and elected by a standing vote of the body at each regular session.

# ARTICLE VI

- 1. Business Session: This State Association shall hold its regular meetings annually. The time of the meetings shall be at 7:30 P.M. on the Thursday before the third (3rd) Sunday in June each year, and shall continue in session until its work is completed - providing notice shall have been served to the clerk of each association composing the state association said notice to have been given at least one (1) month prior to the time of the meeting stating the time and place of meeting.
- This State Association will sponsor a Bible Conference on the Thursday of the conference meeting beginning at 11:00 a.m.
- Adjourned sessions may be called by the moderator or the Executive Committee when conditions demand.

### **ARTICLE VII**

AMENDMENTS: This constitution may be altered or amended at any regular session of this State Association of Free Will Baptists by a two-thirds (2/3) majority vote of those members present and voting at any regular session; provided specific notice of such intended alteration has been given in writing to the clerk and tabled at the last previous day.

### BY-LAWS ARTICLE I

BRINGING THE SESSION TO ORDER: Each session will begin with prayer and congregational singing. After the welcome address and response by the clerk, the clerk will introduce the officers concluding with the Moderator. The Moderator, or in his absence the assistant moderator, will then declare the session to be in order for business. If a quorum is present, he shall then proceed with the business. ("The quorum consists of those who attend the meeting, provided it is either a stated meeting or one that has been properly called." Robert's Rules of Order Revised, 1971.)

#### **ARTICLE II**

MEMBERSHIP RESPONSIBILITIES: It shall be the duty of each body belonging to this association to send a letter to every annual session of this association, reporting in the same its spiritual condition, benevolent work and its statistics. Any local association which fails to report itself for two successive sessions will be considered dropped from this association. Letters and fees will be accepted from district associations with or without delegates (1965).

# ARTICLE III DUTIES OF OFFICERS

### SECTION I MODERATOR

- It shall be the duty of the moderator to call each session to order for business and to preside over all business sessions of this State Association.
- He shall appoint a Nominating Committee consisting of at least three (3) members at the beginning of each session as mentioned in Article V, Section 1B of the Constitution.
- He shall appoint a credentials committee at the beginning of each session.
- He is to see that all business is conducted according to <u>Robert's Rules of Order Revised</u> (1915 edition).
- He is to maintain proper Christian order and not allow discussions when not carried on in a Christian spirit or when he thinks it will cause discord or division.
- He is to preside over any special called meeting between sessions whether called by himself or the Executive Committee.

- He shall seat the delegates in a body in a designated section of the assembly room at the beginning of each business session.
- He is to promote the work of the Virginia State Association. (1977)
- He is to meet with the Executive Committee to plan the Bible Conference and State Association programs.

# SECTION II ASSISTANT MODERATOR

He will help the moderator perform the duties inherent to that office and in the absence of the moderator will perform all of the duties of the elected moderator.

# SECTION III CLERK

- It shall be the duty of the clerk to keep clear, concise, accurate records of all proceedings of this body whether in special session or regular session.
  - The clerk is to compile the letters sent from member Yearly (or District) Associations so as to be sent to the National Association.
  - The clerk is to keep all rulings of this body in order and ready for easy reference.
  - The clerk will introduce the officers of this State Association at the beginning of each session.
  - The clerk is to mail each individual church clerk, pastor and association clerk a notice of the State meeting dates one month in advance noting that each local church is allowed one (1) delegate at the State Meeting. (1986 & 1987)
  - The clerk will meet with the Executive Committee to plan the Bible conference and State Meeting programs and will keep records of these meetings.

# SECTION IV ASSISTANT CLERK

The assistant clerk will help the clerk perform the duties inherent to that position and in the absence of the clerk will perform the complete duties of the elected clerk.

### SECTION V TREASURER

- The treasurer will receive and accurately record all money received by this State Association.
- The treasurer will pay all dues and expenses of this association.
- The treasurer will meet with the Executive Board to plan the Bible conference and State Association programs.

# SECTION VI EXECUTIVE COMMITTEE

- The Executive Board shall have power to act in behalf of and for the state association from one regular session of the association to another, and shall have power to elect such officers as may be necessary for its own government, and to carry out the plans and undertakings of the state association.
- 2. This board shall have power to fill vacancies that may occur in its body, and shall also have power to fill any vacancies that occur in any department of work. It shall be the duty of this board to make written reports of all its work to the next regular session of the State Association.
- This board shall consider whatever business placed upon it, or referred to it by this association or its membership.
- This board shall promote the work of the Virginia State Association. (1977)
- This board will plan each Bible Conference and State Association meeting (1986) along with the Moderator and Clerk.
- This board will set the place for the State CTS competition each year (1988).

# ARTICLE IV DUTIES OF EXECUTIVE SECRETARIES

Their duties shall consist mainly of promoting their respective elected area of interest.

# ARTICLE V CREDENTIALS COMMITTEE

The credentials committee will examine all letters to the State Association and the credentials of the various delegates. The committee shall make recommendations to the Association concerning the seating of delegates.

#### ARTICLE VI

Denominational Enterprises: It shall be the right and purpose of this state association to establish and maintain home missions, publishing houses, orphanages, aged ministers' homes, and summer camps for young people.

### ARTICLE VII STATE HOME MISSION BOARD

- This State Home Mission Board shall be comprised of three (3) members elected on a rotating basis yearly.
- The treasurer of the Home Mission Board will be a member of the Board.
- 3. This board will promote home mission work in this state.
- This board will have its own constitution and By-laws detailing its own responsibilities under the direction and authority of this Virginia State Association of Free Will Baptists.

### **ARTICLE VIII**

Committees as necessary shall be appointed by the chair unless otherwise provided for, and shall hold office until work is completed or until their successors are elected and installed.

# ARTICLE IX RULES OF ORDER

- 1. Everything will be done in decency and in order. (I Cor. 14:40)
- This body will be governed as stipulated in the most current <u>Treatise of the Free Will Baptists</u> unless otherwise plainly stated in this Constitution and Bv-Laws.
- The rules contained in <u>Robert's Rules of Order Revised</u> (1915
  edition) shall govern the society in all cases to which they are
  applicable, and in which they are not inconsistent with the Bylaws or the special rules of order of this society.
- The moderator's rulings will stand unless challenged, seconded and passed by a two-thirds (2/3) majority vote.
- This association shall sit with open doors except when it shall go into a committee as a whole.
- Any person not a member of this association may be allowed to take part in its discussions by obtaining permission of the moderator.
- 7. It shall be the duty of all members of this association to be

- present at the time appointed for each meeting and anyone wishing to retire shall first obtain leave of the moderator,
- 8. No member shall absent himself from the association during its meeting without first obtaining permission from the moderator.
- 9. No person shall be allowed to nominate more than one member of any committee, provided the person nominated be elected.
- 10. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation, "Brother Moderator," but shall not speak further until recognized by the moderator.

11. The "yeas" and "nays" may be taken on any question by request of one-fifth of the members present.

12. No member of this association will be allowed to speak more than ten minutes nor twice on the same subject without permission of the moderator.

### **ARTICLE X AMENDMENTS**

These By-Laws may be altered or amended by a two-thirds (2/3) majority vote of those present and voting at any regular session providing notice of such intended alteration has been given in writing to the clerk and tabled at the last previous day.

# STANDING RULES

- The Association will pay the Moderator, Clerk, and Treasurer \$50.00 per year. (1989)
- Representatives on the National Boards are to be active at the 2. state level. (1974)
- The moderator cannot succeed himself more than one year. 3. (1976)
- The State Association will pay the fee for the youth contes-4. tants to participate in the National competition. (1976)
- The Association will meet in Roanoke each year. (1983) 5.
- Office vacancies are to be filled by those who attend the State meetings regularly. (1987)
- 7. Each member Yearly (or District) Association is to send \$35.00 per church in its association to this State Association for National dues, plus an offering to help defray the expenses of this associational meeting and the printing of the minutes. (1993)

 The State's recommendation to the National Association concerning who will serve as a General Board member of theNational Association will be made and sent with the state report to the National on the even calendar years.

9. Speakers will be given a \$20.00 honorarium.

 These Standing Rules can be changed in any fashion at any regular session by a simple majority vote.
